WiserAdvisor (the "Program") is an advertising and referral service for investment professionals operated by WiserAdvisor. When you provide your contact information through the Program website, WiserAdvisor will introduce you to investment professionals that are in your geographic area, including in your case, an investment adviser representative ("Advisor") of LPL Financial, LLC ("LPL"). It is up to you to interview the Advisor and decide whether you want to hire them. If you decide to hire Advisor, you will enter into an agreement directly with that Advisor to provide you with investment advisory services.
